









NUMBER OF SUPPLIER NCRS


Significant NCR's of the month:

- 1. NCRs are NOT being completed in a timely manner.
- 2. NOT all NCR fields are being populated which is compromising KPI data.
- 3. Process/procedure, human factors and documentation are the main factors of NCRs throughout 2022.
- 4. Significant improvement in effectively recording NCR data.

- 1. NCR No: <u>60427</u> NCR cost: **£1,324.80.**
- 2. NCR No: <u>60422</u>. NCR cost: **£670.68**.


Trends:



Significant NCR's of the month:


1. No significant NCRs this month.

NCR No: <u>70088</u>. NCR cost: **£155.30**.


Trends:

Significant NCR's of the month:

NCR No: 80418. NCR cost: £600.00.

NCR No: <u>21417</u>. NCR cost: **£1,050.00**. *Raised by Engineering*.

Trends:

- 1. NCRs NOT being completed in a timely manner.
- 2. Process/procedure and human factors are the main factors of NCRs throughout 2022.
- 3. NCR 21417 (above) has not been booked against a job number and no suppliers name has been entered. This has compromised KPI data. Root cause has not been defined correctly.
- 4. On Time Delivery is reaching an acceptable level.

Each division are responsible for assessing the KPI data and implementing improvement actions if reasonably practicable. If improvements aren't seen through the KPI data, then the Group Quality Manager will consider adding these as set objectives for the relevant division.
