



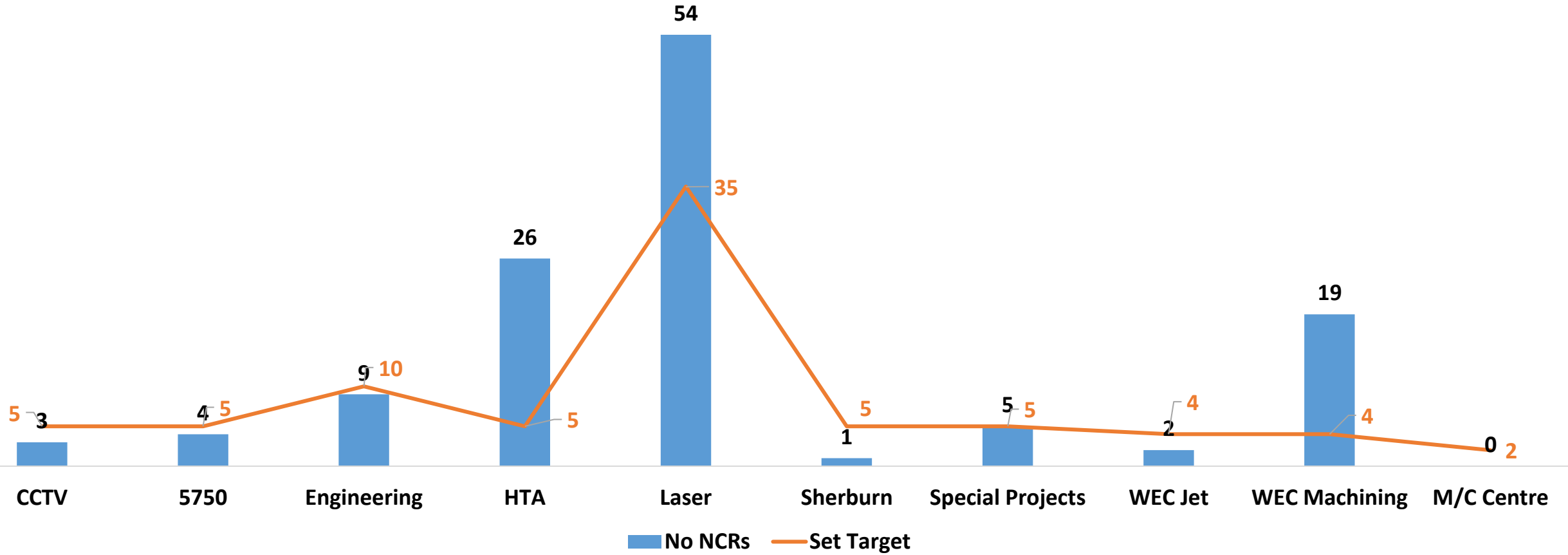

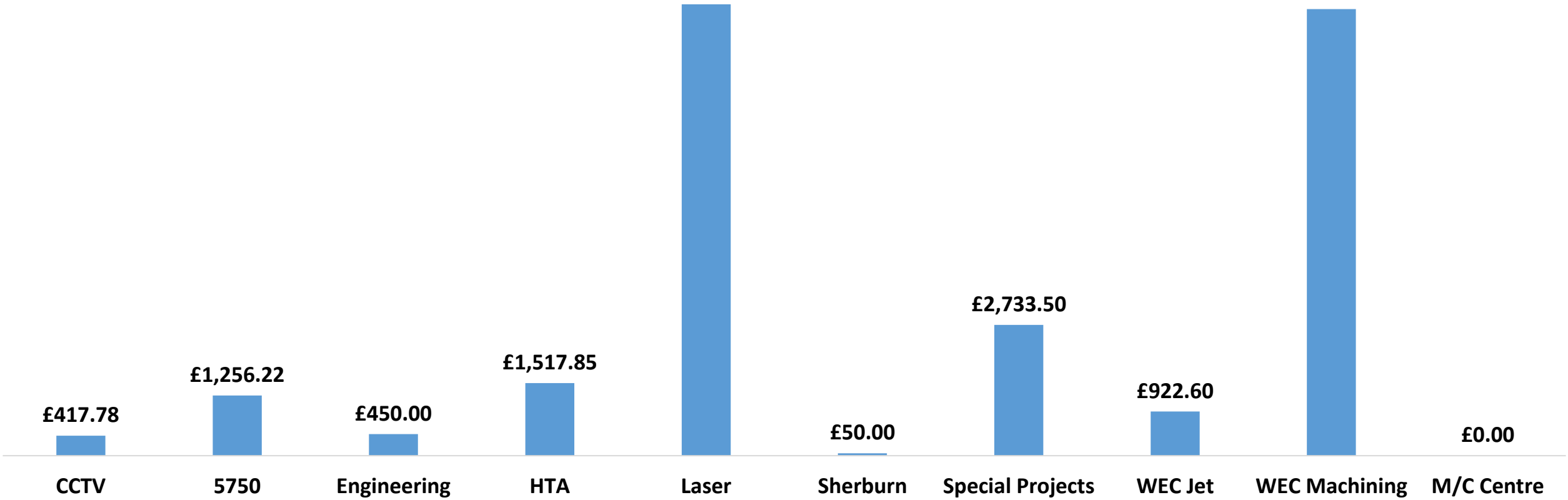
NCR By Division



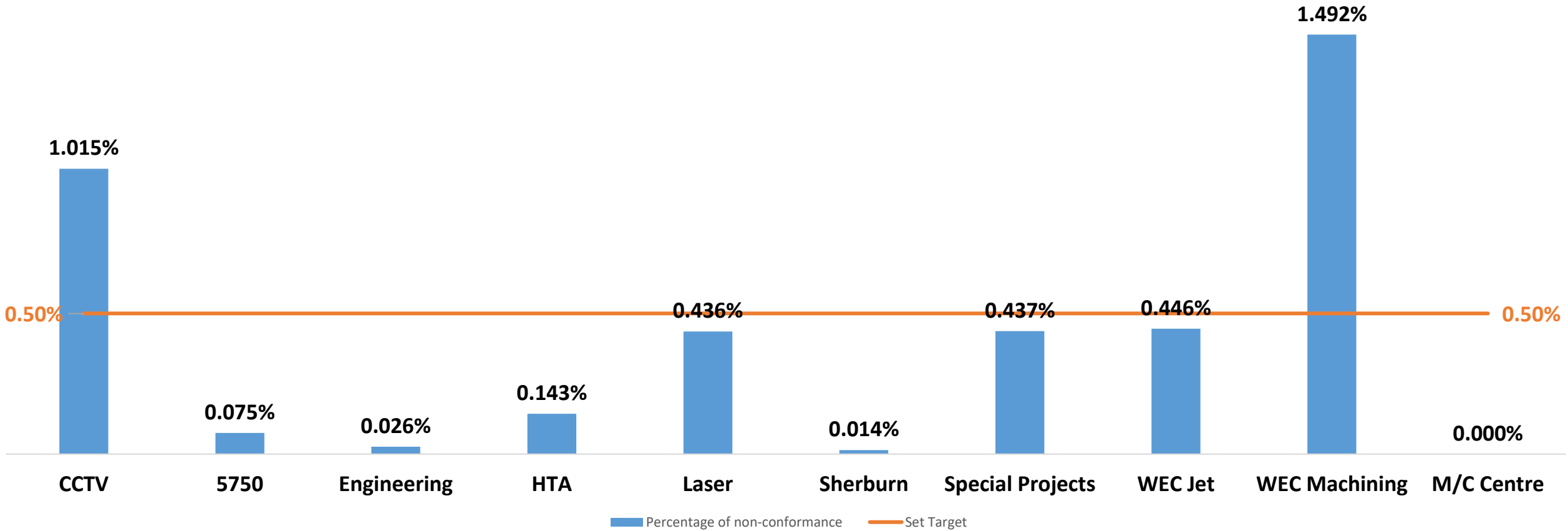
